Following numerous hearings, Lewis obtained a court order requiring the return of the children to Florida and awarding the former husband majority time sharing. He subsequently defended the former wife's appeal, with the appellate court affirming the trial court's ruling.

In another matter, Lewis successfully represented a former husband in a post-judgment alimony modification proceeding, resulting in the termination of the former husband's permanent alimony obligation.

Although the highlighted cases above involved representation of men, Lewis's family law practice represents both men and women equally, with the same dedication, strategic focus, and compassion, regardless of the client's role or circumstances.

Lewis also regularly assists in the preparation of prenuptial and postnuptial agreements, often in collaboration with the firm's Trusts & Estates and Real Estate Departments. This work can involve structuring the conveyance of property to an heir to ensure that a property's non-marital status is maintained and estate planning objectives are achieved.
